

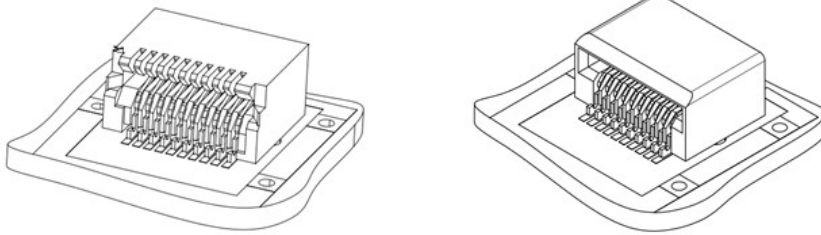

Overview

- 2021 ~ 2022 has caused a global shortage for various grades of resin. This extraordinary event, in conjunction with an already constrained market, has caused immediate and severe disruption in the industry. Due to these supply constraints of LCP marketing, Molex identified the shortage risk of resin supplying which would create a challenge to fulfill all orders. Therefore, a new LCP resin has been identified for relative product.
- Molex team will take necessary qualification action on new source material to ensure the product meets the same form, fit, and function requires as defined in the current Molex product specification and sales drawing.

- **Planned Implementation date.**
